

Door Opening Industry Training Group Sponsorship Agreement

This agreement is made as of this date:	
between DOIT (DOIT) and	(the "Company") at (address)

The parties have agreed to the following terms:

1. Sponsorship Period

- 1.1. The company (herein referred to as the 'sponsor') agrees to sponsor DOIT for the period of one (1) year.
- 1.2. This agreement can be renewed upon agreement of both parties.

2. Sponsorship Amount

2.1. The sponsor agrees to pay a sponsorship fee of (select one) to DOIT, in return for the benefits laid out in this agreement.

Bronze-\$1,000

Silver-\$2,500

Gold-\$5,000

Platinum-\$6,000

- 2.2. DOIT will invoice the sponsor at email address: ________
- 2.3. If the invoice is not paid within 60-days from receipt of invoice, DOIT has the right to delay all benefits until such time the payment is received.
- 2.4. DOIT acknowledges and confirms that unless explicitly written in this agreement, the sponsor will not be liable for any additional cost related to the sponsorship other than the sponsorship fee.

3. Benefits to the Sponsor

Sponsor branding

3.1. Sponsor grants DOIT permission to use the name and logo of the sponsor in the following ways as described in this agreement. It must request and receive written approval to use the logo in any other manner. Use of the sponsor's logo must be in strict accordance with the branding guidelines set out in 5.

Advertising opportunities

All sponsorship levels:

- 3.2. DOIT agrees to publish the sponsor's logo on the Sponsor page of the website, with a link to the Company website.
- 3.3. DOIT will provide the DOIT logo for use on the sponsor website.

- 3.4. DOIT will print the sponsor's logo on marketing materials for on-line and in-person training, including on e-mail advertising for these events.
- 3.5. DOIT will print the sponsor's logo on signage displayed at the in-person training events.
- 3.6. DOIT will accept and make available to students/attendees the following sponsor's marketing material: bags/leaflets/brochures/give-away items (like pens, USB drives, screwdrivers, etc.).

Silver level sponsors and above:

- 3.7. DOIT will award a scholarship in the sponsor's name. (Silver-\$250, Gold-\$1,000, Platinum-\$2,000)
- 3.8. Tabletop (6' x 30" x 30") shall be provided for display of product or company solutions, at Spring and Fall training sessions.
- 3.9. Discount for first three (3) employees of sponsor company registered for Spring and/or Fall training sessions. Must be direct employee of sponsor. (Silver 5%, Gold and Platinum 10%).

Gold and Platinum sponsorship only:

- 3.10. Co-branded (DOIT and sponsor logo) school supplies (e.g., rulers, notepads) may be provided to students at Spring and/or Fall training sessions.
- 3.11. Opportunity to provide 20-minute product/solution presentation to students/attendees at Spring and/or Fall training sessions. Presentation must be reviewed by DOIT prior to presenting.
- 3.12. Opportunity to present one (1) hour sponsor branded product webinar to DOIT audience. Presentation must be reviewed by DOIT prior to presenting.

4. Terms and conditions

Cancellation/ refund policy

- 4.1. This agreement will terminate at the end of the sponsorship period.
- 4.2. Both parties agree the sponsorship amount is non-refundable.

5. Use of Sponsor's Logo & Branding

- 5.1. DOIT must request written confirmation from the sponsor when using the sponsor's logo in any other formats than as agreed above.
- 5.2. DOIT will provide the sponsor with a copy of all print publications with the sponsor's branding, before/after publishing by request.
- 5.3. DOIT shall adhere to any guidelines the sponsor provides in regard to their logo (e.g., adjacency to certain images)

6. Student Data Protection

6.1. Data on student event attendees/subscribers cannot be passed to the sponsor without prior consent of these students. If consent is given, this data is for use exclusively by the sponsor and should not be transferred to any parties without obtaining consent.

7. Sponsor's Relationship with Sponsorship Fee

7.1. The sponsor has the right to be consulted over how the sponsorship fee is spent when a scholarship is being offered in the sponsor's name (e.g., eligibility or exclusions of scholarship recipients). Scholarship applications will be reviewed and selected by the DOIT Scholarship Committee.

This agreement represents the entire agreement between the parties in relation to the subject matter of this agreement and supersedes any previous agreement, whether written or oral, between the parties in relation to that subject matter.
